### **2023 Futurity Rules Weanling Does, Wethers & Bucks**

**Note: DEADLINES WILL BE STRICTLY ENFORCED. Make Sure you meet the postmark deadlines**

1. Any doe whose kids will be shown in the SPPGA Weanling Futurity must be nominated to the Futurity Chairman, Christine Flood, postmarked no later than January 31, 2025. A nomination fee of \$5.00 for doe kids, \$5.00 for buck kids and \$5.00 for wethers must be included along with the doe's name and registration number. \*No late entries on nominations. All dates are final.

2. Only kids born of nominated does and born between 2-1-25 and 3-31-25 may be sustained and shown in the respective Futurities.

3. Any number of kids from the nominated doe's kidding may be sustained by paying a separate sustaining fee for each. NOTE: Specific kids names need be listed at this time, if not registered yet, please list whether they are does, bucks or wethers in the spot for Reg#. \*\*\*If you end up changing a name at time of registry, please notify me.

4. The initial sustaining fee of \$5.00 for each doe, buck or wether kid multiplied by the number of kids to be sustained, must be received by the Futurity Chairman postmarked no later than 4-30-25. A late fee of \$7.50 for bucks, does, & wethers, postmarked no later than 5-9-25 will be accepted. All dates are final.

5. The final sustaining fee of \$5.00 for each doe, buck or wether must be postmarked by 6-6-25. A late fee of \$7.50 for bucks, does, & wethers, postmarked no later than 6-20-25, will be accepted. All dates are final.

You may show as many kids as you wish up to the total number of kids you sustained as of the June 2025 dates.

\*At this time each kid will need to be identified by its registered name & registration number.

6. All Weanling Futurity entries sustained will show in the Weanling Futurity Junior Doe Kid, Weanling Futurity Junior Buck Kid and Weanling Futurity Wether Classes at Goat-Tober-Fest in October 2025. Original registration papers for does, bucks and wethers will be required to be checked by the show Chairman prior to admission to the Futurity Class.

7. Only original NPGA registration papers will be accepted and entries will be judged according to the NPGA Breed Standard.

8. If paying via PayPal, please forward a receipt copy with entries, email or text. Checks, money orders or cash accepted.

9. All Futurity fees collected will be divided and paid as premiums to the top five Futurity placements in the following increments:

**1st - 30% 2nd - 25% 3rd - 20% 4th - 15% 5th - 10%**

(Fees collected for does divided among does only; fees collected for wethers divided among wethers only; fees collected for bucks divided among bucks only)

10. After initial entry, there shall be no refunds for withdrawal for any reason. If the fees are not paid on time, the entry will be disqualified and fees forfeited. The only exception is in the event the show is not held, in which case the Futurity will be canceled and all fees returned to the entrants, minus any Futurity expenses already incurred.

11. If the nominated doe or any kid is sold, its Futurity rights continue to the new owner subject to the foregoing rules. Premiums will be paid to the owner at the time of the show as verified by registration papers.

12. All Futurity entries must be tattooed or micro chipped to be shown.

**Doe, Wether and Buck Kids entered in the 2025 Weanling Futurity will be eligible for the 2026 SPPGA Yearling Futurity.**
