Note: DEADLINES WILL BE STRICTLY ENFORCED. Make sure you meet the postmark deadlines

Yearling Does/Bucks & Wethers

<u>Doe, Buck and Wether Kids entered in the 2024 Weanling Futurity,</u>
even if not shown in 2024 Futurity will be eligible to enter for the 2025 Yearling Futurity.

- 1. Only yearling Does, Bucks and wethers that were sustained in SPPGA's 2024 Weanling Futurities may be entered & sustained for the SPPGA Yearling Futurities in 2025
- 2. A nomination fee of \$5.00 Does, Bucks, & Wethers along with the Doe/Buck/Wether registered name and NPGA registration number must be sent to the Futurity Chairman, postmarked no later than 1-31-25. A late sustaining fee of \$7.50 for Does and Bucks & Wethers will be accepted if postmarked by February 14, 2025. All dates are final.
- 3. A sustaining fee of \$5.00 does, bucks & wethers must be received by the Futurity Chairman, postmarked no later than 3-1-25. A late sustaining fee of \$7.50 for Does, Bucks & Wethers will be accepted if postmarked by March 14, 2025 All dates are final.
- 4. A final sustaining fee of \$5.00 for each Doe & Buck & Wether must be <u>postmarked by April 4, 2025.</u> A late sustaining fee of \$7.50 for Does, Bucks & Wethers will be accepted if <u>postmarked by April 11, 2025.</u> All dates are final.
- 5. All Yearling Futurity sustained entries will show in the Yearling Futurity Doe, buck or wether class at the May 2025 SPPGA show. Original registration papers will be required to be checked by the Show Chairman at the time of check-in. They will be judged according to the NPGA Breed Standard.
- 8. If paying via PayPal, please forward a receipt copy with entries, email or text. Checks, money orders or cash accepted.
- 7. All Futurity fees collected will be credited accordingly to Does/Bucks/wethers and will be divided and paid as premiums to the top five Futurity placements in the following increments:
- 1st 30% 2nd 25% 3rd 20% 4th 15% 5th 10%
- 8. After initial entry, there shall be no refunds for withdrawal for any reason. If the fees are not paid on time, the entry will be disqualified and fees forfeited. The only exception is in the event the show is not held, in which case the Futurity will be canceled and fees returned to the entrants, minus any Futurity expenses already paid.
- 9. If the nominated Doe/Buck/wether is sold, its Futurity rights continue to the new owner subject to the foregoing rules. Premiums will be paid to the owner at the time of the show as verified by registration papers. All Futurity entries must be tattooed or micro chipped.
